1. The *United Republic of Tanzania* has received a Loan from the Export-Import Bank of Korea from the resources of the Economic Development Cooperation Fund (EDCF) of the Republic of Korea in the amount of **70,000,000 US Dollars** toward the cost of *Improvement of Sewerage Services in Dodoma Capital City Project* and intends to apply a portion of the proceeds of this loan to payments under the contract for *Construction of Sewerage Networks in Dodoma City Project, Contract No.TZA-14*.
2. The Project Executing Agency (Dodoma Urban Water Supply and Sanitation Authority) on behalf of the Borrower now invites sealed bids from eligible bidders for *Construction of Sewerage Networks in Dodoma City Project*.
3. Bidding will be conducted through Competitive Bidding (CB) procedures specified in the Guideline for Procurement under EDCF Loans, and is open to all eligible bidders that meet the following minimum qualification criteria. Large with Experience on Construction of Sewerage Network Contracts in the role of Main Contractor for at least two (2) for the last fifteen (15) years prior to the submission of this Bid. As used in this clause, "Sewerage Network Construction Contract" refers to a construction project for a treatment plant, regardless of its capacity, or a sewer line construction project exceeding 50 kilometers in length.

4. Interested eligible Bidders (as per **Section V** of the bidding document) may obtain further information from Dodoma Urban Water Supply and Sanitation Authority and inspect the bidding documents at the address below from 08:00 to 16:00 hours (East Africa time) on weekdays.
5. A complete set of bidding documents may be purchased by any interested Bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of USD1,000.00, the payment in Tanzanian shillings shall be paid through control payment number provided by DUWASA after being converted from USD to Tanzanian shillings (TZS) during the time of purchase using the exchange rate provided by Bank of Tanzania (BoT)
6. Bids must be delivered to the address below at or before time: 2:00 p.m., **Date: 5<sup>th</sup> February, 2025**. All bids must be accompanied by a bid security of USD 2,400,000 (two million and four hundred thousand US Dollars). Late bids shall be rejected. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below at time: 14 hours, East Africa time.
7. The *Dodoma Urban Water Supply and Sanitation Authority* will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of Bids.
